**All Members are required to pay a \$10.00 (non pro-ratable) Issues Mobilization Fee, which will continue each year until the Issues Mobilization Fund reaches \$5 million. The fee is administered by the VAR Public Policy Advocacy Group and the VAR Board of Directors. The fund is to be used by Local Associations and VAR to advocate critical public policy issues on behalf of members and private property rights

Attn: All DAAR members, dues are billed in two installments. The first installment of \$275 is due on December 1st. If you join between Jul 1- Nov 30, you will be responsible to pay the next dues installment by Dec 1. The second installment of \$355 is due on June 1st. If you join between Jan 1-May 30, you will be responsible to pay the next dues installment by Jun 1.

Secondary Members

Secondary members pay only the DAAR dues, unless their primary association is outside the state of Virginia.
Out-of-state Secondary members pay DAAR dues, VAR dues, and the VAR application fee.

SentriLock Keys

1. DAAR Membership Dues do not include a one time Key Processing fee of \$50.00.
2. SentriLock KeyCard charges are due annually. The annual lease fee, pro-rated quarterly, is due at the time of issuance.
3. Fees with tax included are as follows: Dec-Feb - \$136.50; Mar-May - \$102.38; June-Aug - \$68.25; Sep-Nov - \$34.13
4. Leases made in November may be charged the pro-rated amount plus the annual fee if the billing has been generated.
5. Non-member keyholders DO NOT pay association dues. KeyCard costs for non-members will be the same as for members including a one time \$50 processing fee.
