FREQUENTLY ASKED QUESTIONS

Do I have to belong to a local association?

Yes. Once the principal (s) decide to join the REALTOR[®] association, then all agents, brokers and appraisers who are licensed or affiliated with him or her have the option of also joining as members of the association. Membership with the association gains you discounted access to the local MLS as well as the DAAR administered preferred lockboxes for your

What's the difference between a REALTOR® and a real estate agent?

The term REALTOR[®] is a registered trademark that can only be used by members of the National Association of REALTORS. Upon joining a local association, you will have the exclusive use of the term REALTOR[®].

Do I have to pay VAR & NAR dues?

Yes. When you join DAAR you will also pay dues to the National and State Associations.

Can I join DAAR as secondary member?

Yes. REALTORS[®] and Designated REALTORS[®] may choose to belong to DAAR as secondary members to access member benefits like our education programs, events, and discounts. They pay local dues only. A letter of good standing from the REALTORS[®] primary Association is required.

Does DAAR offer installments to pay dues?

Yes. DAAR collects members dues for the state and national association before the first of the year. Local dues are collected mid-year during the annual membership period.

Can I pay my SentriLock[®] fee through DAAR?

Yes. Following new key set-up, payment for your SentriLock® subscription renewal is collected before the first of the year.

How do I sign up for MRIS?

DAAR recommends for you to sign up for MRIS after your DAAR membership has been processed for added benefits. Contact MRIS directly at 1.800.833.8138 once your membership has been approved and processed

What is RPAC? Do I have to contribute?

RPAC (REALTORS[®] Political Action Committee) ensures that your interests are represented when laws, ordinances and regulations are being enacted. Through voluntary monetary contributions of REALTORS[®], RPAC supports the campaigns of candidates whose outlooks, decisions and stances are compatible with those of REALTORS[®] and property owners. RPAC is a voluntary contribution and is not required for membership at DAAR.
