Fair Housing Month

DAAR commemorates the 50th Anniversary of the Fair Housing Act of 1968 by providing our 1,500 REALTOR® and Affiliate members with the opportunity to learn more about Fair Housing and advocate for inclusion and diversity in our communities. April began with DAAR receiving a Fair Housing Act Resolution from the Loudoun County Board of Supervisors on April 3rd. On April 18th, DAAR held a two-hour course on Fair Housing. The month ended as DAAR partnered with the Loudoun County De-

Loudoun County Budget News

On April 3rd, the Loudoun County Board of Supervisors finalized the county's budget for Fiscal Year 2019 (FY2019). The \$2.64 billion budget provides funding for the Loudoun County government and public schools. The budget is based on the equalized real property tax rate of \$1.085, \$0.4 cents lower than the current tax rate of \$1.125. FY2019 begins July 1, 2018. Loudoun County Increases the Number of Staff Dedicated to Housing

The County's FY2019 budget includes funding for three new positions to address one of the most critical needs in Loudoun County – how to provide housing that is affordable. Two of the three new spots will be housed in the Family Services Department and one will be housed in the County Attorney's office. While five new positions were originally proposed, DAAR is pleased to see the addition of a Housing Financier, Real Estate

Short-Term Rental Registration Update



If approved by the Board of Supervisors in May, Loudoun County staff will put in place a registration process for people who rent out a residential room or space for under 30 days at a time (a short-term rental). Beginning in July 2018, short-term rental owners will be required to provide information about their rentals to the County. While it will be free to register, there is a penalty of \$500 per violation up to \$5,000 total. Real estate licensees and people represented by a real estate licensee are exempted from registering. Dedicated Funding Plan for Metro Receives Final Approval in Virginia

Virginia will provide \$154 million a year to support the Metro transit system. On April 18th, the Virginia General Assembly approved funding Metro through a combination of existing sources, without an increase in the grantors' tax ("congestion relief fee"). Throughout the process of approving Metro funding, members of the Dulles Area Association of REALTORS® (DAAR), Northern Virginia Association of REALTORS® (NVAR), and the REALTOR® Association of Prince William (PWAR) worked very hard to minimize the impact on the real estate industry. General Assembly Update

The 2018 Virginia General Assembly was extremely successful for the Virginia REALTORS®. All of the bills on Virginia REALTORS® 2018 Legislative Agenda have been signed into law! These laws will become effective July 1, 2018 unless otherwise indicated.

Real Estate Team Legislation–Del. Peace (<u>HB862</u>)/Sen. Sturtevant (<u>SB758</u>). Defines a "team," requires teams be licensed, and requires contact information of the supervising broker be included in brokerage agreements. Effective Jan. 1, 2019.

Translation of Documents to Non-English Language– Del. Bulova (<u>HB439</u>)/ Sen. Mason (<u>SB528</u>). Authorizes a real estate licensee to refer a party to one or more translation services so the party can contract directly with a translation service of their choosing. In doing so, the real estate licensee assumes no liability for inaccuracies made by the translator.

Earnest Money Deposits (EMD)/Broker Education/Post-License CE–Del. Ingram (<u>HB864</u>)/ Sen. Sutterlein (<u>SB514</u>). Establishes in statute a right for disbursement of EMDs in accordance with the real estate purchase contract. Effective January 1, 2019, two of the eight-hour broker education hours will specifically cover VREB and COV supervision requirements. Real estate finance will also be added to the existing curriculum.

COA/POA–Del. Bulova (<u>HB923</u>). Requires CICs to: 1) provide a short summary of the information contained in the resale certificate or disclosure packet; and 2) deliver it at the same time as the Resale Certificate or Disclosure Packet. This summary will provide buyers with items that could affect their decision to purchase the property, such as: annual dues, special assessments, and restrictions (rental, parking/ vehicular, pet, or architectural).

Acceptance of Rent with Reservation– Del. Peace (<u>HB855</u>)/ Sen. Locke (<u>SB197</u>). Clarifies existing law by removing the requirement that the tenant be given a second notice of acceptance of rent with reservation after the eviction order has been granted.

Lexington Short-Term Rental Ordinance– Del. Knight (<u>HB824</u>). Requires the City of Lexington to comply with state law re: short-term rentals. The City has until Sept. 30, 2018 to come into compliance.

Clarification of Supreme Court Case– Del. Simon (<u>HB311</u>). In an unlawful detainer cased filed by a successor landlord, the general district court determines if there is a valid issue as to legal title of the property.
