## What the Association Health Plan Rule Means for REALTORS®

The U.S Department of Labor (DOL) has finalized its long-awaited Association Health Plan (AHP) rule to expand the definition of "employer" to include "working owners." This change allows real estate professionals and other self-employed individuals to participate in association health plans. A key provision, forwarded for inclusion in the rule by NAR, will allow many REALTORS® who have access to coverage through a spouse to be eligible to choose an AHP option. #### County Plans for More Broadband Service

The Board of Supervisors recently adopted a new plan to bring more broadband service into the county! The plan outlines five (5) strategic goals and some of the steps needed to achieve those goals. While benefitting all of Loudoun County, two of the five goals include a focus on western Loudoun: attract more broadband investment to expand coverage; and improve coverage for public safety and first responders. The other county-wide goals are to: leverage county and school communications services to maximize the amount of shared infrastructure; encourage "smart" technology, such as expanding broadband infrastructure along major corridors; and provide student access to high-speed broadband. Some of the strategies are already underway including the Broadband Infrastructure Study and the Broadband Infrastructure Expansion capital project with LCPS. ### It's Time for Non-Exempt Short-Term Rental Owners to Register their "Rooms for Rent"

Non-exempt short-term rental owners are now required to register their short-term rental units in Loudoun County. A short-term rental is a residential room or space that is rented out for under 30 days at a time. While it will be free to register, there is a penalty for noncompliance of \$500 per

violation, up to \$5,000 total. **Real estate licensees and people represented by a real estate licensee are exempted from this registration process.** Learn more about implementation of the registry by visiting <a href="www.loudoun.gov/ShortTermRentals">www.loudoun.gov/ShortTermRentals</a>

The National Association of REALTORS® or any fits state associations or local boards will not favor or disfavor any member because of the amount contributed. NAR has established state Federal RPAC Disbursement Allocations based on anticipated National RPAC needs. Thirty percent of all Major Investor contributions are sent to NAR to be applied to the Federal RPAC Disbursement Allocation and are charged against the limits under 2 U.S.C. 441a with the remaining seventy percent maintained for state and local usage. Decisions regarding Virginia REALTORS® RPAC contributions to meet the Federal RPAC Disbursement Allocation will be made throughout the fundraising year.
