Get Your Real Estate Team Ready for the New Year!

Are you working as a real estate team? Did you know that if you work with at least one other person and advertise as a team there are new regulations that impact you effective January 1st, 2019? Join us to learn about the new regulations and how they may impact how you operate. New Regulations for Real Estate Teams will be held on Friday, November 16th, 9 -11AM at DAAR, Ashburn.

Featured speaker and industry legal expert Sarah Louppe Petcher, S and T Law Group, will provide an overview of the new rules requiring teams to form a business entity (LLC, S Corp, Partnership, etc.) and obtain a business entity license, as well as the requirement that brokerage agreements must include the name and contact information of the supervising broker. This class if free for DAAR REALTOR® members, \$24 for non-members.

Did you know that about 79% of REALTORS® in Loudoun County vote? Let's make that 100% this year! On the November ballot will be candidates for United State Senator, United States House of Representatives, two Constitutional Amendments, and two Loudoun County bond questions. Attention Brokers and New Licensees — **New 2019 Education Requirements**

Beginning January 1, 2019, all brokers and new licensees (1 year or less) will have new education requirements. No hours were added to either broker requirements or PLE, however both have some of the existing hours allocated to specific topics.

Brokers must complete 2 hours of education learning about the broker supervision requirements in both the Code and the regulations as part of their already required 8 hours of education.

Two hours of post-licensure education for licensees must be about real estate-related finance. All active new salesperson licensees must complete a Board-approved 30-hour post-license education (PLE) curriculum within one year of obtaining a salesperson license in order to remain on active status. For example, if your salesperson license was issued on January 1, 2015, you must complete all 30 hours no later than December 31, 2015.
