SentriLock Keys:

DAAR Membership dues do not include SentriLock dues or the one time key processing fee of \$50.00.

SentriLock card renewal fees are due annually and pro-rated quarterly.

Fees with tax included are as follows: Dec - Apr 7 \$137.80; Apr 8 - Jul 7 \$103.35; July 8 - Oct 7 \$68.90; Oct 8 - Jan 7, 2021 \$34.45.

Optional card reader is a one time fee of \$26.50.
