B. Limited License To Partner. Partner hereby agrees to indemnify, save and hold harmless DAAR and its employees, officers and directors from and against any and all claims, damages, judgments, settlements, costs and expenses (including reasonable attorneys' fees and expenses) which may arise by reason of (i) any act or omission by Partner or any of its officers, directors, employees or agents and/or (ii) the inaccuracy or breach of any of the covenants, representations and warranties made by Partner in this Agreement. DAAR shall promptly notify Partner upon receipt of any claim or legal action referenced in this Section.
